## Objectives and investment policy

### Objective

To grow your investment over the long term (five years or more) through a combination of income and capital growth after all costs and charges have been taken. The Fund aims to deliver this return with a cautious risk profile. There is no guarantee that the objective will be met or that a positive return will be delivered over any time period and you may get back less than you invest

### Investment Policy

To invest at least 70% of the Fund's assets (usually funds managed by other fund managers) in investments with positive environmental and/or social themes while seeking to avoid investment in activities that the Portfolio Manager considers harmful to the environment and/or society. The Portfolio Manager's responsible investing framework for selecting and monitoring investments comprises: (1) ESG integration - assessing the explicit inclusion of environmental, social and governance (ESG) factors in the investment processes of issuers of investments (usually other fund managers); (2) Negative screening - limiting investments with exposure to certain sectors, companies or countries deemed harmful to the planet or society by: (i) only including an investment where revenue derived from specified activities is within the Portfolio Manager's defined tolerance threshold, and (ii) excluding investments found to be in violation of any of the UN Global Compact Principles regarding human rights, labour, the environment and anti-corruption; (3) Pursuing positive environmental and/or social themes - investing in holdings that have: (i) a demonstrable influence (such influence may vary between investments) on a defined environmental and/or social theme(s) (themes may vary from time to time); (ii) an explicit goal(s) linked to a theme(s); (iii) a clear investment policy to achieve the stated goal; and (iv) evidence of progression towards the goal; and (4) Engagement - engaging with the issuers of investments to drive positive change. In most instances the Portfolio Manager will assess the extent to which other fund managers seek to influence the behaviour of issuers of investments in which their fund invests, rather than engaging directly with companies or issuers.

The Fund may invest directly and indirectly in equities (which are shares in companies), bonds (which are loans to either a company or government that pay interest), property, commodities (for example gold), hedge funds, money market instruments (which are short term loans that pay interest), deposits and cash. The Portfolio Manager determines the mix of asset classes and geographic areas to achieve the Fund's objective, and then on an ongoing basis assesses economic conditions and market opportunities and will adjust the amount invested in the different asset classes, geographic areas and industry sectors accordingly. The cautious risk profile of the Fund is managed to a volatility level (a measure of the fluctuation of returns in different market conditions) that is less than 125% of the volatility of the Comparator Benchmark. There is no guarantee that this level of volatility will be achieved and at times, the Fund's volatility may be higher

### Other Features

The Fund is actively managed. The Portfolio Manager uses its expertise to research and select investments aimed at achieving the Fund's investment objective. The Fund may invest in other funds (including those managed by the Manager, the Portfolio Manager and their associates). The Fund will not invest in property and commodities directly, but by using, for example, other funds. Whilst the Fund can invest in different asset classes it may not have exposure to all asset classes at all times. The Fund is part of a range of four responsible funds that are managed according to different risk profiles. Funds with a higher risk profile will have a larger allocation to higher risk investments such as equities. This Fund has the second lowest risk profile in this range and the second lowest expected return. The Fund can invest in different geographical areas and industry sectors without limitation. Derivatives (investments whose value is linked to another investment, or to the performance of a stock exchange or to some other variable factor, such as interest rates) may be used for investment purposes and to manage the risk profile of the Fund.

### Comparator Benchmark

The Fund's performance may be compared against a composite index comprising indices representing different asset classes: 11% MSCI UK Index (GBP) - total return net (representing UK equities); 27% MSCI ACWI ex UK Index (GBP) - total return net (representing global equities, excluding UK); 17% ICE BofA UK Gilt 5-10 year Index - total return gross (representing UK government bonds); 17% ICE BofA US Treasury 5-10 year Index (GBP hedged) - total return gross (representing US government bonds); 23% ICE BofA Global Corporate Index (GBP hedged) - total return gross (representing corporate bonds); and 5% SONIA one-month - total return gross (representing cash). The composite index has been selected as an appropriate comparator as it is representative of the main assets in which the Fund is likely to invest in proportions that are consistent with the Fund's risk profile. The Fund's actual holdings may bear little resemblance to and may include assets that do not form part of, the Comparator Benchmark. The Comparator Benchmark is re-balanced quarterly to the constituents of its component indices for the purpose of calculating the performance of the Comparator Benchmark.

### Recommendation

This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

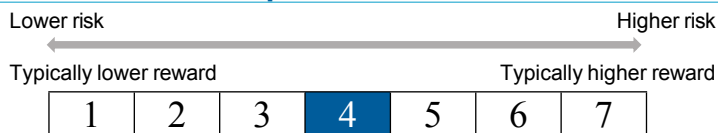
### Dealing

## Risk and reward profile



### The Risk and Reward Indicator

The calculation of the risk and reward indicator is based on 5 years of historical (actual or simulated) information so may not be a reliable indication of the future risk profile of the Fund. The risk and rewards indicator of the Fund is not guaranteed and may change over time.

The risk and reward profile is classified by the level of historical fluctuation (i.e. volatility) of the Net Asset Values of the class, and within this classification, categories 1-2 indicate a low level of historical fluctuations, 3-5 a medium level and 6-7 a high level. A category 1 fund is not a risk-free investment – the risk of losing your money is small, but the chances of making gains is also limited.

### Other Risks

The risk category does not take into account the following material risks:

**Currency Risk:** As the Fund can be exposed to different currencies, changes in exchange rates may decrease the value of your investment.

**Derivative Risk:** A derivative may not perform as expected and may create losses greater than its cost.

**Emerging Markets Risk:** The Fund may invest in emerging markets, which are markets in countries that are developing. Emerging markets may have more political and economic risks than developed markets, which may result in large and frequent price movements that may cause a loss to the fund.

**Changes in Interest Rate Risk:** A rise in interest rates generally causes bond prices to fall.

**Credit Risk:** The value of a bond may be affected by its credit rating, the lower the rating the higher the risk of the issuer not paying interest or repaying the loan.

**Property Fund Investment Risk:** Property funds can become illiquid increasing the risk that a position cannot be sold in a timely manner or at a reasonable price.

**Counterparty Risk:** The failure of a counterparty providing services to the Fund may expose the fund to financial loss.

**Responsible Assets Risk:** The Fund restricts its investments in certain sectors, companies and investments in accordance with the Portfolio Manager's Responsible Investment Policy. This may result in the Fund having a narrower range of eligible investments compared to other funds, which may in-turn affect the Fund's performance. If an investment is no longer in accordance with the Responsible Investment Policy it will be sold and the price obtained may be less than could be obtained if a forced sale was not required. Investments that demonstrate positive environmental or social characteristics may fall below the 70% minimum threshold due to market movements, market conditions or in times of market stress.

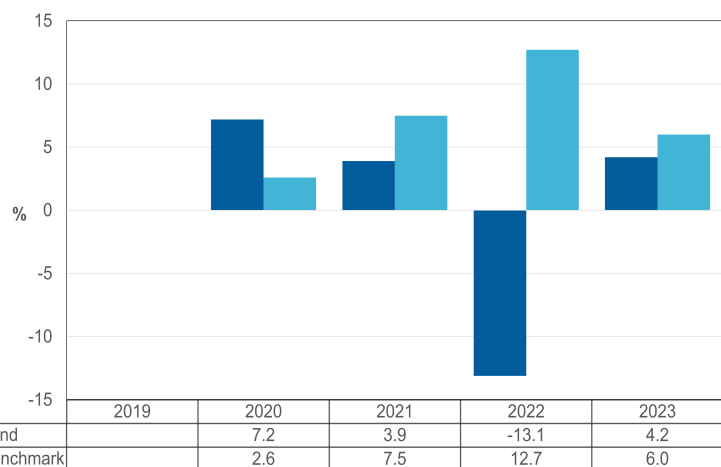
The Ongoing charges figure is based on expenses as at 31 October 2024 and this figure may vary.

## Past performance



This chart shows how much the Fund increased or decreased in value as a percentage in each year.

Performance has been calculated in GBP and takes account of ongoing charges.

The Fund launched 08 July 2019 and the Class was launched on 08 July 2019. On 01 December 2024, the Fund changed its investment objective. The performance before this date was achieved under circumstances that no longer apply. On 01 December 2024 the Fund removed its target benchmark and its previous two comparator benchmarks; and introduced a new comparator benchmark. The benchmark performance displayed prior to this date reflects the previous target benchmark (CPI + 2%). The Fund name was changed from Handelsbanken Cautious Sustainable Multi Asset Fund to Handelsbanken Cautious Responsible Multi Asset Fund in December 2024.
