Share Class C

Investment objective

To deliver a total return (the combination of income and capital growth) that at the end of any five year period is the equivalent of achieving a return of the Consumer Price Index plus 4% each year over that period, after all costs and charges have been taken. There is no guarantee that the objective will be met or that a positive return will be delivered over any time period and capital is at risk.

Investment policy

To invest globally in a broad range of asset types such as equities (shares in companies), bonds (loans to either a company or government that pay interest), property, commodities (e.g. gold), hedge funds and cash. The fund may gain exposure to these assets directly, by investing in securities issued by companies and governments, and indirectly, for example by investing in other funds. The fund may also invest in derivatives (investments whose value is linked to another investment, or to the performance of the stock exchange or some other variable factor, such as interest rates) for investment purposes and to manage the risk profile of the fund.

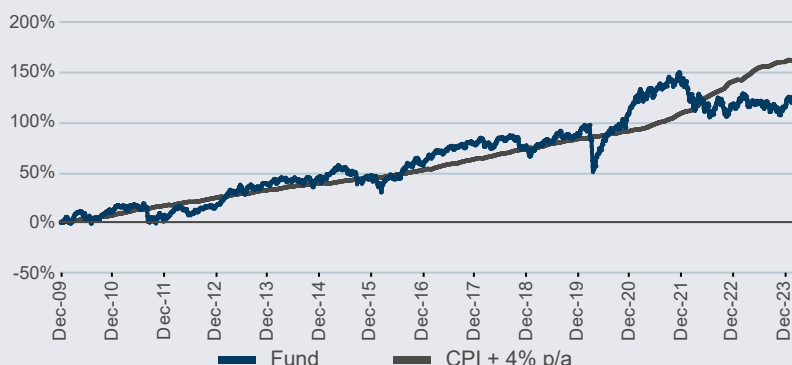

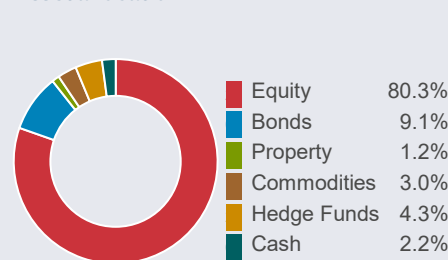

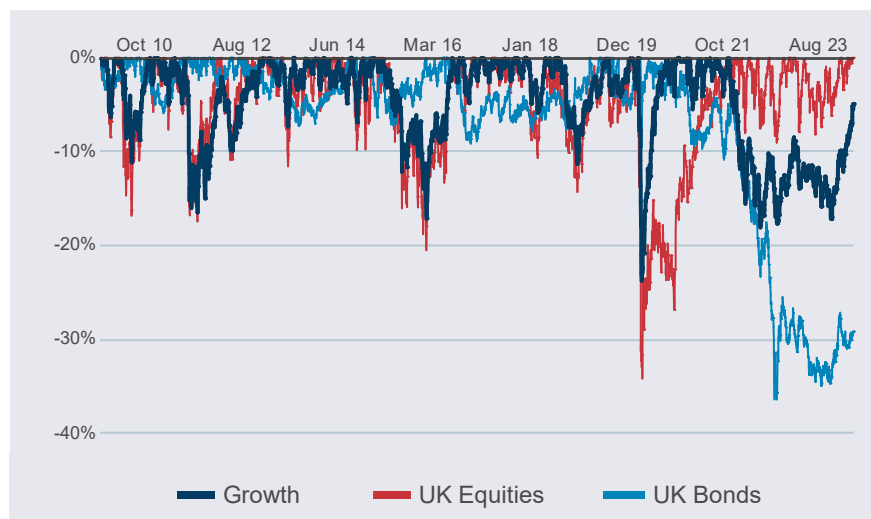

Downside risk (since inception)

Investors may be subject to tax on their distributions; **Investment Grade:** bonds issued by a company with a medium or high credit rating from a recognised credit rating agency. The fund's target return benchmark is CPI (The Consumer Price Index) + 4%. CPI + 4% has been selected as the fund's target return benchmark as the fund aims to achieve a return (the money made or lost on an investment) that is 4% above the rate of inflation. The Consumer Price Index is used to measure the rate of inflation. As performance data is produced prior to the publication of the latest monthly CPI data, the most recent figures are extrapolated one month until the ONS publish the latest figures. The latest figure may be higher or lower than that shown, and will be included in the following month's performance data. Please refer to the fund's Investment Objective for details regarding how achievement of the target return benchmark is measured, and over what time period. The fund's performance may also be compared against UK Equities represented by MSCI United Kingdom Index (£, net total return) and UK Government Bonds represented by ICE BofA UK Gilts Index (£). These comparator benchmarks have been selected as they assist in evaluating the fund's performance against the two principle asset classes that the fund may have exposure to. The share class of the fund was launched on 30 November 2009, performance figures do not exist before that time.
